3. Discussions and motions agenda items that may be on NWNC March 13, 2012 agenda are below:
 - a. Updated motion to add extra funding up to total of **\$920** for the Reseda Blvd eight tree planting project for labor to excavation and install up to 8 trees. The added extra cost for labor to excavation and install the 8 trees at \$115 each tree is \$920 from Four Seasons Nursery. Funding to come from Line # 310 Community Based Events unallocated fund with current balance of \$3,320 and if approved the Line # 310 Community Based Events Unallocated fund balance will be \$2,400 plus if revised NWNC Budget 2011/2012 is approved then \$62.49 will return to Line # 310 Community Based Events Unallocated fund with new balance of **\$2,462.49**. Already have funding for 8 trees from NWNC board on line # 323 Plants & trees Reseda Blvd. for \$800 (8 trees at \$90 each in a 24' box plus sales tax) from Four Seasons Nursery. **Originally tabled from NWNC Feb. 14, 2012 meeting. (Beautification - Williams)**
 - b. What does NWNC Beautification Committee what on Reseda Blvd. Bench proposal for NWNC went the 3 NC's (NWNC, NSNC & NENC) meet on Wed. March 28, 2012 at 7PM at CD12 which will have representative from Bureau of Street Services to attend. www.bss.lacity.org
 - c. **Motion to return not used funds from Signage templates prep (Kinkos copying) of \$100, \$220 of \$445 for N/W Wilbur/Lassen garden project and \$500 for soil amendment back to line #310 Community Based Events Unallocated for total of \$820. This may be included in revised NWNC Budget 2011/2012 motion by NWNC Budget/Finance Committee instead on NWNC March 13, 2012 agenda.**
 - d. Cost to plant Superior Street median between Tampa and Corbin as needed with ivy, and to have the sprinklers tested and repaired.

- e. Diagnose sprinkler system on Tampa median between Devonshire and 118 Freeway.
- f. Cost and procedure to hang banners spotlighting volunteerism or the military, on one of our major boulevards.
- g. Look at using some funds from line #350 Equipment Maintenance Volunteer materials, etc. and other line fund items under line #320 Beautification.
- h. Four cans of spray paint for painting signs to do white letters which will cost \$28 (4 cans x \$7 each = \$28) and take funds out of line #350 Equipment Maintenance Volunteer materials, etc. or under #320 Beautification.
- i. Provide status for the following assignments:
 - 1) Hiring watering truck to water Tampa medians cost (Brian),
 - 2) More parkway mowing and status of the existing SK Landscape mowing contract (Ron),
 - 3) Spraying or removing infected pine trees cost (Freddie),
 - 4) Power spraying the Reseda Blvd sidewalks cost (Steve).
 - 5) Providing Community Improvement category budget status (Glen)
 - 6) Getting commitments from Reseda Blvd businesses to water the 8 new trees (Sherry)
 - 7) Street sweeping cost (Jo)
 - 8) Need price on a major one time clean up of the Reseda Blvd median south of Lassen St. (Sherry)
