  - a) \$8648-\$2500 for First Aid Training \$3000 Calahan \$2500 Miller \$1000 CERT Training Committee Recommendation is to ask Beautification for \$2500 to fund Miller NPG
  - b) Jeff Fox presented request for funding depressions & Bipolar Support Alliance (DBSA Northridge) in the amount of \$650. Committee Recommendation to fund up to \$650 Vote: 8-0-0
