Call to Order and Roll Call

- President Peter Lasky called the meeting to order and welcomed ten stakeholders, along with nine board members. John Mah performed the roll call.

1. Pledge of Allegiance

- Peter Lasky led us in the Pledge of Allegiance.

2. Reports and Presentations by Public Officials

- Jessie Strobel, Field Deputy for Councilmember Englander, reported the following:
  - Councilman Englander recently voted no on street vending as well as to decriminalize street vending.
  - Tuesday, January 31, Councilman Englander submitted a motion to the City Council directing the LADWP to immediately report to the City Council on its efforts to implement clean energy storage projects within the city. Additionally, the motion asks LADWP to report on the feasibility of partnering with local investor-owned and municipal-owned utilities to implement clean energy storage projects.
  - Wednesday, February 8, Councilman Englander submitted a motion requesting that the LADWP report to the City Council in thirty days on options to reduce the City's reliance on natural gas usage and storage near local communities. This motion was unanimously approved.
  - In addition, Councilman Englander voted yes on a resolution to shut down Aliso Canyon.
  - The City Council unanimously approved an ordinance based on Councilman Englander's motion to provide all full-time city employees who are activated as members of the National Guard, Naval Militia, or any reserve component of the armed forces, to receive the difference between their city and military salary, and ensure that they continue to receive their medical, dental and life insurance benefits for the duration of their military assignment.
  - Thursday, February 16, 6-8PM, there will be a Great Streets networking event along Reseda Boulevard, between Parthenia and Plummer Streets.
  - Thanks to the 50+ attendees of the CD12 Speaker Series at Councilman Englander's office, and a special thanks to Gabriella Karin and Robert Geminder for their insightful dialogue on "The Anatomy of Hate" from the perspective of Holocaust Survivors.

3. General Public Comments on Non Agenda Items

- Glen Bailey, President of the Northridge East Neighborhood Council (NENC) reported that they would meet Wednesday, February 15. The agenda includes a presentation on Measure M, as well as a mayoral candidate forum at 8PM. Prior to the NENC meeting, many of the mayoral candidates will attend a neighborhood council meeting in Hollywood.
- The Department of Neighborhood Empowerment's (DONE) Gracie Liu attended the February 9 meeting of the Valley Alliance of Neighborhood Councils (VANC); the following recommendations were discussed:

- Revocation of online voting
  - Elimination of the voting documentation requirement
  - Potentially lower the voting age to 12
  - The results will be submitted to Councilman Herb Wesson.
  - A recent Board of Neighborhood Commissions (BONC) meeting was held in Woodland Hills (not exactly “north” valley). Wednesday, February 22, BONC will have their north valley meeting in Tujunga at 6PM.
  - The VANC will have their annual anniversary mixer on Thursday, March 9 in Studio City. RSVP is required for studio security, as well as to ensure that they have enough food.
  - VANC has recently developed a liaison program for homeless, animals, filming, purposeful aging in place, as well as emergency preparedness; the liaison can be a board member or a stakeholder.
4. Guest Speaker: Jay Beeber, Proponent of Measure S, Yes on S- Preserve LA
- The January NWNC meeting had the No on S side of this debate.
  - Jay Beeber is active with the North Hills West Neighborhood Council (previously with the Sherman Oaks Neighborhood Council), and is the San Fernando Valley liaison for Yes on S.
  - Jay feels that the city planning system is broken, as the city does not follow the rules that are already in place. In 2005, the city code was amended so that they would not have to update the zoning regulations every five years.
  - There may be areas where zoning should be changed, but 90% of developers get their way. An area near the Beverly Center limits buildings to 45’, a developer wanted to build something over 200’; as a compromise, the zoning regulators permitted the building to be over 100’.
  - Oftentimes, the developer chooses who does their Environmental Impact Report (EIR); hence the EIR’s writer sides with the developer.
  - Yes on S will require that zoning meeting be held on nights and weekends, so that working people can attend.
  - 95% of construction in LA is by right, so it will not affect construction jobs. In addition, it is perfectly legal to build houses on commercial property.
  - Contrary to rumors, Measure S will not restrict homeless housing as passed last November via Proposition HHH.
  - The No on S campaign is funded by the billionaire developers, and supported by Mayor Garcetti, United Way, LAPD, LAFD, and most of the City Council.
  - Yes on S was put forward by the AIDS Healthcare Foundation (AHF), which has saved millions of lives worldwide. A great many rent controlled housing units have been destroyed. When the AHF patients get kicked out of their rent-controlled housing, it is difficult for them to remain in touch for their medicine. The entire AHF board voted to support S.

- Thursday, March 30, at 6PM, at the Northridge Park’s gym on Lemarsh Street, there will be a meeting to discuss the sober living house on Los Alimos Street. Councilman Englander, Bill Larson from the City Attorney’s office, a representative of Assemblyman Dante Acosta’s office, as well as someone from the Probation Department will attend.

- Two people have already moved into the sober living house on Los Alimos Street, and they have already had an incident with the LAPD and paramedics.
  - C. Resignation of Lloyd Dent as Secretary and Chair of the Bylaws Committee and Standing Rules Committee.
    - Sad to report, Lloyd Dent has resigned as Secretary, Chairman of the By-Laws Committee, and Standing Rules Committee.
  - D. Thursday, February 23, 6 to 8PM, at Emle’s Restaurant, 9250 Reseda Boulevard, the graduate students of CSUN’s Department of Urban Studies and Planning, alongside Northridge Sparkle, the Northridge Neighborhood Councils, and CD12, will host an open house to get feedback on the best ways to redesign, rebrand, and re-imagine Reseda Boulevard between Nordhoff and Lassen Streets and east to the CSUN campus. Join the community and provide your thoughts on branding, design ideas, and visual preferences to develop a plan to enhance connectivity and build identity between Reseda Boulevard and the CSUN campus. The students would love to hear everyone’s suggestions.

13. Reports by Liaisons:

A. Budget Representatives

- o There was a comparison with a group home that had so many people living there that a few of the residents resided in tents in the back yard. Often, they cannot make it to the bathroom, so they bag their excrement, and toss it over the wall into the neighbor's yard.
