- Don Larson would like to focus on Reseda Boulevard, from Nordhoff to Devonshire Streets.
- Stakeholder Peter Wei asked for the budget breakdown.

- After their clean-up activities, the "navigator" helps the homeless get jobs and housing.
- Don originally requested \$5k for this program. Jon Manuel added that with this \$3k, NWNC would have granted \$7k to the Clean Streets program during this fiscal year, which is nearly 17% of the annual budget.
- Colleen Pick and Bill Fox are 100% in support of this as Don is a known entity and the money stays in Northridge.
- Bill Fox made a motion to approve this NPG expenditure; Colleen Pick seconded the motion, and it passed: Aye (7) Dent, Fox, Kromhout, Lapaz, Lasky, Pick, and Wilson. No (2) Heckscher and Manuel. Abstain (1) Bolin Absent (1) Williams

NWNC requested an update on project status multiple times to include dates, locations and number of workers to ensure work had been completed

- Email dated June 21st, 2019 from Peter Lasky to Don Larson requesting documentation of work completed as well as future work being funded. (attachment 3)
- Email dated July 4th from Peter Lasky to Don Larson requesting work records for NPG. (attachment 4)
- Email dated August 13th to Linda Dunham, Don Larson associate, providing clarification to questions. Additional emails confirming Don Larson and NBF received the NPG funding. (attachment 5)
- Email dated August 30th from Don Larson to Peter Lasky (Attachment 6)
- In person meeting requested by NWNC Board for September 23rd Beautification Committee Meeting. Mr. Larson did not attend but sent Chris Sales, NBF board member, to represent him. Mr. Sales did not come prepared to address the issue or provide support

for work completed. He suggested we go to Don's Facebook page and look for pictures. He, nor Mr. Larson followed up with pictures or documentation of work performed. (Beautification Meeting Minutes – attachment 7. https://northridgewest.org/wp-content/uploads/docs/BeautM 2019-09-23.pdf)

NPG #2 Dated May 3rd, 2019 (attachment 8)

May 14th, 2019 General Board Meeting Minutes (attachment 9. https://northridgewest.org/wp-content/uploads/docs/Minutes 2019-05-14.pdf) reflect the following:

#17. Discussion, presentation and motion to approve \$5,000 NPG on six-week program on cleaning and improving in areas to be determined with funds going to Northridge Beautification Foundation (NBF). SFV homeless folks receive gift cards for roughly three hours of work a day, twice a week. The program runs three hours a week/twice a week for six to ten individuals. This is modified if there are fewer participants. All participants must sign in to ensure accountability and transparency.

- The NBF's Clean Streets/Clean Starts Program started along Reseda Boulevard in Northridge to assist the homeless and beautify Northridge. This program has since been requested throughout the San Fernando Valley to help improve communities and alleviate homelessness.
- Don Larson works with five to fifteen homeless individuals who clean the parks, paint
 the hydrants, and other tasks that are not handled by the city. Realtor Chris Williams also
 helps with street clean-up activities.
- The NBF receives funding via NPGs from all the area's neighborhood councils.
- Gail expressed concern about \$5,000 calculates to \$23/hour. Don replied that the homeless receive \$30/day in the form of a grocery gift card (which cannot be used for alcohol, cigarettes, or lottery tickets). If there is money left over, he extends this service to another week, or banks the money for future endeavors.

NWNC requested an update of when work would be completed to fulfill the new NPG.

- Puring the September 23rd Beautification Meeting Chris Sales requested a list of what work the NWNC Board would like completed for the \$5,000 NPG. The Board followed up with a detailed list of expectations including streets, hours, and timeline. (attachment 10, https://northridgewest.org/wp-content/uploads/docs/Minutes 2019-10-08.pdf included in both the October General Board Meeting minutes item #9 as well as an email to NBF and Don Larson)
- Correspondence dated October 8th, 2019 between Peter Lasky and Don Larson regarding the Tampa Median Topiary project and the Clean Streets program. (attachment 11). This correspondence contradicts his NPG request for Clean Streets on May 14th, 2019.
 - Per email dated Oct 8th, response from Don Larson
 #9. Discussion and Motion from the Beautification Committee of a work request for cleaning major streets in Northridge West by the Northridge Beautification

Foundation to satisfy the NPG received by NBF in May of 2019. The following streets are the streets selected, Reseda, Wilbur, Tampa, Corbin, Nordhoff, Plummer, Lasson, Devonshire and Chatsworth. Cleaning would consist of removing debris, leaves, trimming trees, and shrubs and weeding. (Sooter 10 minutes)

(Don Larson response): To be clear, all of the streets mentioned have been cleaned in the past, some multiple times. Another detail to remember is that this program is a homeless work and improvement project. I have not cleaned streets in the Valley for the last number of years because I decided to start a second job as a gardener or even as a contractor for clean ups. This is an entire program that has proved successful all over the valley and which your NC understood when you "hired" me for the job. Linda Dunham, who is currently visiting family in the East, will continue to organize financial data from the last cleanup in preparation for enlightening you, your BoD members, and stakeholders as to what goes into a successful clean up.

Again, your future clean ups can be coordinated, as required, but they will not be taking place until my current projects are finished.

• As of December, Don Larson and NBF have not responded to the work request with a commitment to completing the NPG.

NPG #3 Dated May 3rd, 2019 (attachment 12)

May 14th, 2019 General Board Meeting Minutes (attachment 9. https://northridgewest.org/wp-content/uploads/docs/Minutes 2019-05-14.pdf)reflect the following:

#18. Discussion, presentation and motion to approve \$4,000 NPG to be used to maintain the topiary installed in 2018 by trimming, weeding, and watering as necessary to fund Northridge Beautification Foundation.

- Kelly mentioned that this was extensively discussed on NextDoor. Many criticized Don because they felt the topiary did not look like horses. Per Don, he owns horses and he knows what they look like.
- Rana and Lloyd asked about the maintenance, watering, and the length of this financial commitment. Don replied that NWNC might need to contribute money for this upkeep for the next few years.
- Kathleen asked how long the topiary would take to grow; this may take three years. Don may add moss to fill in the horse's chest cavity to expedite matters.
- Councilman Krekorian has asked Don to extend his topiary activities into his district, including North Hollywood and along Sepulveda Boulevard.

2. Comments by Public Officials

- Matt Hernandez, Public Safety Field Deputy for CD12, is the liaison who advocates for the stakeholder's behalf while interfacing with the Departments of Building, Safety, Transportation, as well as the LAFD, LAPD, etc.
- In March, the city council's Budget and Finance Committee approved Councilman Englander's legislation to establish a seismic retrofit loan program for at-risk woodframed properties.
- Colleen Pick expressed concern about wayward shopping carts. It is recommended that one contact the council office. Via text, they will communicate with those who can oftentimes remove the carts within hours.
- Saturday, April 21 will be the 25th Annual Supporters of Law Enforcement in Devonshire (SOLID) All You Can Eat Pancake Breakfast beginning at 8AM for \$9/person, and the LAPD Devonshire Division's Annual Open House beginning at 10AM. - Matt had two available tickets to SOLID's pancake breakfast, and coordinated a trivia contest. Among the questions asked were "how many sub-committees are park of the NWNC?" (too complicated) and "which neighborhood council put on an outstanding town hall on Thursday, March 29?" (too obvious). The final trivia question was "What do you fill out to address the council?" The answer was "a speaker card".
- Jose Galdamez from the Department of Neighborhood Empowerment (DONE) reported the following:
 - Sunday, April 15 is the deadline for Neighborhood Councils to amend their bylaws.
 - The funding deadlines for this fiscal year (ending Saturday, June 30) is Sunday, May 20, with Wednesday, June 20, being the last day for credit card transactions.
 - In April, DONE will host Planning 101 Project Planning workshops; this training will provide an overview of the basic elements of planning, land use, and zoning. The valley classes will be as follows:

South Valley Monday, April 30 6PM to 8.30PM

- Congratulations to the board for the great job everyone did at the March 29 town hall meeting.
- The NWNC received a letter from landscape architect Robert Gutierrez addressed to the city's Office of Community Beautification; the proposed topiary has been approved.
- Peter asked who is the most responsible element for how committees operate? President? Board? It was a trick question, as it is dependent upon the stakeholders. In accordance with the NWNC bylaws, a committee can have merely three board members, but it can have many stakeholders.
- 6. Discussion and motion to require all Neighborhood Purpose Grant (NPG) Applicants to have a representative attend and speak for the proposed grant at the general board meeting where the board will vote on the grant
 - Lloyd Dent mentioned that this allows for transparency, as well as the opportunity for board members and stakeholders to ask questions. He then made a motion to approve this agenda item; Jenni Heckscher seconded the motion, and it passed unanimously.
- 7. Discussion and motion to approve a recommendation by the Education Committee to approve the NPG of \$1,000 for the Oakridge Foundation for the planting of a large Oak Tree. This was approved in February but rejected by the City Clerk NC Funding Division because of an improper date
 - Peter Lasky and Stakeholder Brian expressed concern about the date shown on the NPG.
 - Although there was no one from the Oakridge Foundation, Pamela Bolin requested that we vote on it anyway, as it was already approved in February.
 - Stakeholder Peter Wei asked about the source of the \$1k estimate; the Oakridge Foundation received several cost comparisons and determined that number was valid. A second presented opinion was not warranted.
 - Pamela Bolin made a motion to approve this agenda item, provided that the corrected NPG be returned to the NWNC within thirty days, by May 10; Lloyd Dent seconded the motion, and it passed unanimously.
- 8. Discussion and motion to approve a recommendation by the Education Committee of an NPG for \$3,000 for the Northridge Beautification Foundation for the purpose of cleaning and improving areas to be determined by the board such as Devonshire Street, Tampa Avenue, or other busy and highly visible through fares in our boundaries
 - Don Larson would like to focus on Reseda Boulevard, from Nordhoff to Devonshire Streets.
 - Stakeholder Peter Wei asked for the budget breakdown.

 - ⇒ Brian reminded Chris that NPG language states that "Upon completion, applicant must submit a follow up form to the Neighborhood Council and Department of NC" which has not been done.

 - B. \$4k for NBF for maintaining the Tampa Median, dated May, 2019. Maintenance includes weeding, trimming and shaping the topiary and fixing and repairing the sprinkler system if needed and for additional topiary to be installed if permits are obtained.
 - Per Peter, Don had said that he wanted to be responsible for getting permits for future topiaries.
 - \Rightarrow The Board requested an update to the changes Don agreed to on the existing topiaries dated July 23, 2019
 - ⇒ The Board would like to understand what steps Don is taking to secure permits for future topiaries.

2. Comments by Public Officials

- Newly inaugurated Councilman John Lee addressed the NWNC
 - John started working with the area neighborhood councils while supporting Councilman Joel Wachs in the mid-90s.
 - He recently submitted a motion to fund overtime to support extra manpower for the LAPD at the Devonshire and Topanga Divisions. He also started a task force to deal with local street racing in the northwest valley. This effort has resulted in forty racing cars being removed from our streets. He also had cameras installed at major intersections.
 - John, along with Supervisor Barber, made a motion for the Hidden Creeks open space to remain undeveloped, rather than having 100+ homes built on that site.
 - John hopes to schedule a meeting with Governor Newsom to discuss the permanent closure of Aliso Canyon. There may be a major announcement regarding this by the end of October.
 - Lloyd asked about a requirement that new houses capture rainwater; John replied that they
 are working on that issue.
 - Gail Lapaz asked about a new homelessness supportive housing project that is being built along Topanga Canyon Boulevard. This can be built as three stories; however, the developers would like it to be a four-story structure. John added that the Los Angeles Homeless Services Authority states that 25% of the area's homeless are mentally handicapped who need institutional assistance; that statistic may be closer to 70%.
 - A stakeholder asked about a potential bridge across Sesnon Boulevard from Reseda
 Boulevard to Granada Hills; that bridge could cost \$25m and there is no plan to develop it.
 - O Glenn Bailey asked about sidewalk vendors who are blocking sidewalks and hurting small businesses. Many citizens have reached out to Building and Safety as well as Street Services, who have done nothing since 2018. John told the story of Emle's Restaurant at 9250 Reseda Boulevard. A complaint was issued that someone got food poisoning from eating fried chicken from the sidewalk vendor in front of this restaurant. Emle's had to undergo an inspection, even though it was not their food.
 - For further issues, John recommended that people reach out to him via email at councilman.lee@lacity.org.
- Danni Wang, communications director for Assemblywoman Christy Smith addressed the NWNC.

- The state assembly is out of session until January. If you want Ms. Smith to partner with your association, please reach out to their office.
- Ten bills from Ms. Smith were considered by the senate, with seven awaiting Governor Newsom's signature:
 - Assembly Bill (AB) 543 makes school sexual harassment resources accessible
 - AB 629 helps victims of human trafficking get back on their feet
 - ABs 967 and 1507 update the California Charter Schools Act, creating clarity and equity
 - AB 1233 waives AP exam fees for low-income students and foster youth
 - AB 1637 streamlines the unclaimed property request process
 - AB 1729 increases high school enrollment in summer community college courses.
- o Governor Newsom already signed the following four bills from Assemblywoman Smith:
 - AB 853 expands college affordability by allowing ScholarShare to pay for expenses associated with college, such as rent and textbooks
 - AB 1051 updates the course load cap for nursing faculty to build the pipeline of nurses
 - AB 1106 extends the Enhanced Homeowner's Notification Program to save homes from foreclosure
 - AB 1336 champions child safety by funding more childhood injury prevention programs.
- Abigail Bailes expressed concern about sex education curriculum and how this class material will be relayed to parents.
- Tara Vahdani, School Engagement and Data Specialist for LAUSD Board Director Scott Schmerelson, addressed the NWNC:
 - She joined Scott's team three months ago, and supports 510 schools throughout the San Fernando Valley.
 - Scott is chairing the LAUSD Committee on Special Education, including monthly meetings with an advisory committee comprised of forty parents. He wants to ensure that they are happy with the special education that their kids are receiving. If anyone is interested in serving on this committee, please reach out to Scott and Tara's office.

- DONE's new General Manager, Raquel Beltran will be the featured speaker at the October 10th meeting of the Valley Alliance of Neighborhood Councils (VANC).
- VANC's November planning forum will be held at the CBS Studios, Studio City whereupon they will discuss land use issues. This year's meeting has a sponsor, so they are not requesting neighborhood council's contributions.
- Victoria Estrada spoke earlier with Tara regarding the upcoming sex education curriculum coming to the LAUSD in 2020. She does not believe that the LAUSD wants parents to know what they will teach the children. Children as young as kindergarten will learn about masturbation, children in 4th grade will receive birth control information (including condom usage), and 7th graders will learn about sex with all genders. She would like the NWNC to agendize this issue.
- Grace, the mother of three boys, agrees with Victoria and is alarmed by what is taught in the LAUSD. She feels this material is not appropriate for 9-and 11-year-olds and yet she was told that she could not opt out. The school told her that she is one of a very few people who are concerned about this. She agrees with Victoria that this should be agendized at an NWNC meeting.

Peter:

Just wanted to let you know that I will not be able to attend the meeting described below because of my need to be "early to bed, early to rise" for my clean up program. Also, whatever is agreed on in the future, in terms of dates for carrying out any work, will need to take into account the other demands on my time that are represented by requests from CD 12, other council members, and from our county supervisor and her staff.

8. Discussion and Motion from the Beautification Committee requesting a funding line of up to \$5,000 to be used for Public Art. The funds will be used to paint electrical boxes at traffic lights or other Public Art projects yet to be identified. The Beautification Committee will present locations, cost per box, and samples of the art, or ideas for other projects at a future meeting, funding to come from the Community Improvement Budget. (10 minutes, Sooter)

Item #8 is a bit of a different process than what had been previously discussed (median topiary). Normally, "painting" the mechanical boxes or identifying other locations for public art would require you to work with an artist or public art group, through an NPG. The public art that we had agreed on was for development of median topiary. I understand that you would prefer to have store bought topiary shells and other plants for the planting. I would remind you that the plants chosen for the first topiary were those suggested by the city street services folks, of which you "insisted" that we follow their suggestions. However, we can plant other plants in the future. I cannot guarantee the long term survival of these structures since the store purchased versions are very flimsy. I am also in the process of making good on a request to alter the "heads" of the horses. The time frame for continuing on the project will be late December or early next year.

9. Discussion and Motion from the Beautification Committee of a work request for cleaning major streets in Northridge West by the Northridge Beautification Foundation to satisfy the NPG received by NBF in May of 2019. The following streets are the streets selected, Reseda, Wilbur, Tampa, Corbin, Nordhoff, Plummer, Lasson, Devonshire and Chatsworth. Cleaning would consist of removing debris, leaves, trimming trees, and

shrubs and weeding. (Sooter 10 minutes)

To be clear, all of the streets mentioned have been cleaned in the past, some multiple times. Another detail to remember is that this program is a homeless work and improvement project. I have not cleaned streets in the Valley for the last number of years because I decided to start a second job as a gardener or even as a contractor for clean ups. This is an entire program that has proved successful all over the valley and which your NC understood when you "hired" me for the job. Linda Dunham, who is currently visiting family in the East, will continue to organize financial data from the last cleanup in preparation for enlightening you, your BoD members, and stakeholders as to what goes into a successful clean up.

Again, your future clean ups can be coordinated, as required, but they will not be taking place until my current projects are finished.

Thanks for taking a moment read this. I hope we understand where we all stand now. If you or your stakeholders continue to be concerned about the quality or the reliability of my work, I suggest that you contact John Lee, Supervisor Kathryn Barger, Councilmember Blumenfield, or any number of notables to ask for a recommendation.

Don,

I took a stab at ghost writing some comments that would help "fill in" what is happening with the horses. I tried to pull from your comments, but I don't know if I got everything. I kept it to aesthetic and did not attempt to address structure (A frame, etc) as I felt that was more in line with what people are looking for. Feel free to use this as a starting point.

The horses were designed to allow for growth. In order to do that

- o Manes and tales are temporary and will be replaced with wire mesh that will allow the plants to fill in the shapes
- Legs are left open so that the plant can grow. As it grows the legs will be shaped to allow for better skeletal definition
- The topiaries are anchored in cement to allow for stability to withstand our high winds.
- The black container at the base of the legs are water pipes to allow for watering, not the plant containers
- o The ears are a little oversized to allow for growth. It will be less evident once the plant begins to adhere to the wire
- o Moving forward, I will make some adjustments to the nose and ears that will give more definition to the facial characteristics

Don,

I'm writing to you to clarify the board position on matters regarding Neighborhood Purpose Grants (NPG's) given to Northridge Beautification Foundation (NBF).

As you know there have been some concerns raised by the board about 3 of the 5 Neighborhood Purpose Grants that NBF has received from the Council in the last 2 years.

The first question concerns the grant received in May of 2018 for \$3,000. The issue raised by the board is whether this work was done. NBF's Application Request states that "The grant money will be used for a 6 week program designed for 10-15 people."

Page 2 of the Grant Request, Section III, 10c states that ("After the completion of the project, the applicant must submit a follow up form to the Neighborhood Council and the Department of Neighborhood Empowerment)"

In spite of several requests for proof showing that this work has been done, said proof has not been furnished.

In a previous email you stated that you had turned over the request to Linda Dunham who would furnish the above evidence. Ms. Dunham has not offered this evidence. We've been very patient in waiting for this evidence to be furnished, approximately 6 months. If no evidence is furnished we will have to assume that the terms of the NPG have not been met.

More recently at the May 14, 2019 Meeting, NBF received an additional 3 Neighborhood Purpose Grants of which the board has concerns regarding 2 of them.

"\$5,000 was approved for the purpose of "cleaning and improving in areas to be determined modeled after the Northridge Great Street project".

You stated in response to a question from Pam Bolin that night that NBF accounts for the grant money received from the council with time cards showing the location worked, the name of each recipient, and the hours worked. With this method of accounting it should be easy to document the work referred to above has been completed.

At the September 23rd Beautification Committee Meeting, Chris Sales, appeared per your request as a representative for NBF. He requested that the board submit to NBF a request of what work NWNC would like done to satisfy this grant. The Beautification Committee has created this work list and the Council has approved it. The intent is to provide guidance to NBF as to the board's priorities. We are asking that NBF provide an approximate date of when this work will be completed.

The minutes from the September Meeting show that the board unanimously approved this work list below.

"Discussion and Motion from the Beautification Committee of a work request for cleaning major streets in Northridge West by the Northridge Beautification Foundation (NBF) to satisfy the NPG received by the NBF in May 2019. The following streets are selected: Chatsworth Street, Corbin Avenue, Devonshire Street, Lassen Street, Nordhoff Street, Plummer Street, Reseda Boulevard, Tampa Avenue, Wilbur Avenue. Cleaning would consist of removing debris, leaves, trimming trees, and shrubs and weeding. Someone mentioned that water would not be included. Rana Sharif made a motion to approve this agenda item; Kelly Sooter seconded this motion and it passed unanimously."

The other NPG approved at the May Meeting was for \$4,000 for Tampa Median work. Among several items enumerated it states "if permits are obtained for putting additional topiary on the medians, install additional topiary animals per the California Rancho theme, such as goats, chickens, sheep, cows etc."

"Northridge Beautification will use their best efforts to work with the Bureau of Sanitation to have them reapply compost material to the medians."

In previous discussions you (Don) have stated that you would like to take over the responsibility of obtaining permits for additional topiaries and adopting the medians. You have stated that you could obtain these permits faster than the board with your "connections" and it would give you more direct control over the future topiary projects. It would also make it easier for the Council not to have do the work to adopt the medians, obtain the permits and remove the Council from the responsibilities in accepting permits from the city.

As of now you have not disclosed to the council any intention to move ahead with adopting additional Tampa Medians, permits or to install additional topiaries.

The following are from the minutes of the September 23rd Beautification Committee Meeting where Mr. Sales spoke on your behalf:

"The Beautification Committee would like to understand what steps Don is taking to secure permits for future topiaries.

"The Beautification Committee needs to determine if there will be additional topiaries for the Tampa Median. If yes, a recommendation will be needed to determine if the topiary frames are purchased or built by Don. Regardless Don would install them per the terms of the NPG."

"Per Chris, if we decide that we don't want to move forward with topiaries, then the money should either be refunded or reallocated to another project."

"Peter requested that Don come back with a recommendation of what the next topiary would be. He (Don) has the money, the materials- he should make the presentation."

Per Chris, Don has been able to manipulate the city to do things we would not normally get done."

I am reaching out in this email as there has been little conversation between you and I or the Council since NBF received the funding for the last 2 Grants. I hope that questions regarding the past and present NPG's can be resolved in a way that is satisfactory to the Council and NBF.

We all acknowledge that you and NBF have done amazing work and are well deserving of the recognition and accolades received. Non the less there can be honest differences of opinion between people/organizations and they should be dealt with in a straight forward manner.

We look forward to hearing your response regarding these issues.
