Attached, please find your current, approved Northridge West Neighborhood Council Bylaws, formally approved on June 30, 2020.

Below are the changes:

- Article V: Governing Board
 - Section 4: Term and Term Limits - Correction made to the board seat name. Open-At-Large to Community Interest Stakeholder seat.
 - Section 8: Censure - Department added the Board of Neighborhood Council Censure Policy language
 - Section 9: Removal of Governing Board Members- Department added the Board of Neighborhood Council Removal Policy language
 - Section 10: Resignation - Does not require the board to take action to accept a board resignation.
- Article VI: Officers
 - Section 1 - lists all the executive officers
 - Section 2 - grammar corrections
- Article VII: Committees and Their Duties
 - Section 1: Recently approved committees added.
- Article IX: Finances
 - Sub-Category E removed
- Article VIII: Compliance
 - Section 2: Training - Code of Conduct was added.

Finally, throughout the process, edits were made to correct grammatical and formatting errors.

Your Bylaws are attached in PDF format for public/online posting and distribution, as well as in Word document format to facilitate future revisions your Board may wish to draft.
