THE BROWN ACT

THE PURPOSE OF THE BROWN ACT IS TO ALLOW "FULL PUBLIC DISCLOSURE" AND TRANSPARENCY

- A. At Board Meetings, ONLY agenda items may be discussed, EXCEPT a brief response to public comments or questions, brief presentation of activities of Board members, and suggestions for future agenda items.
- B. Agendas must be posted to allow them to be viewed by the public
 - 72 hours in advance for regular meetings
 - 24 hours in advance for Special Meeting
- C. Board members must REFRAIN from discussing board business, in person or through technology, with a voting majority of the Board.
 - No more than 3 members for full Board; Less for committees.

THE BROWN ACT CONT...

D. Common Mistakes

- 1. Serial Meetings a series of separate communications, that in total, involve a voting majority of the Board or committee members, for purpose of developing a majority to take action. Ex: When four or more board members, privately communicate and discuss between themselves their plans, goals, recommendations, intents, etc.
- 2. Reply All emails about agenda items to a voting majority of the Board
- 3. Incoming emails and letters to the Board Will be addressed or assigned to a Committee Chair, by the President. The President is the official representative of NWNC for public relations responses and issues, unless the President authorizes a board member in their absence

THE BROWN ACT CONT...

- Discussing logistics, such as meeting dates, times and process are NOT Brown Act violations
- Ad Hoc committees are not subject to Brown Act restrictions
- Social, ceremonial, or conference gatherings, where Board business is NOT discussed, are OK
- Violations of the Brown Act maybe punishable by the Department of Neighborhood Empowerment

- Check your NC Board email regularly.
- Absences Any Board Member who misses 3 regularly scheduled consecutive NC GBMs, or 4 total GBM during any 12 month period shall be automatically removed.
- Be prepared: Read minutes, review the MER, and other items in advance.
- NC Training: All board members must complete ethics, funding, and code of conduct trainings in order to vote. The training courses and instructions can be found at http://empowerla.org

COMMUNITY IMPACT STATEMENTS

- Community Impact Statements are official statements adopted by an NC on issues pending before the city's decision makers.
- CISs were created specifically for NCs to publicly express their support, opposition, or suggestions about any matter pending before the City Council, its committees, or City commissions.
- Tip: While the CIS allows NCs to communicate collectively, board members and stakeholders can continue to communicate their views individually. A submission reflecting the opinion of a single individual is called public comment/public communication.
