Neighborhood Purposes Grants

Neighborhood Purposes Grants (NPGs) provide NCs opportunities to develop partnerships with local 501(c)(3) nonprofits and public schools to build community and enhance neighborhoods in the City of Los Angeles. Projects and activities supported by NPGs vary widely and can include, but are not limited to:

- The Arts
- Beautification
- Community Support
- Education
- Community Improvements

NPG-funded projects and activities must be for a **public benefit** and purpose, **open**, **accessible**, and **free of charge** to stakeholders.

Grants approved by NCs exceeding \$5,000 involve further review and possible City contract by the Office of the City Clerk.

There are two NPG Information Packets; One for prospective applicants to help guide them in the application process, and one for NC board members outlining considerations and factors to keep in mind while evaluating NPG requests.

A “Project Completion Report” template is also provided to help ensure accountability in the use of Grant funds and help demonstrate how NCs and their partners are supporting L.A. communities and stakeholders. NCs and NPG recipients are strongly encouraged to work together to complete and submit the Report at the conclusion of the project.

SECTION II - PROJECT DESCRIPTION

4) Please describe the purpose and intent of the grant.

In the upcoming months, the Robodox has ambitious plans to expand the reach of STEM to TK-12 kids. First, we plan to build and design two new robots from scratch. One of them is a Pine Needle Bot that will collect pine needles from community streets which helps mitigate storm flooding by clearing the gutters and assisting the storm drains. Additionally, we are building another robot to provide students the opportunity to receive hands-on engineering training (programming, mechanical, electrical, and computer design) and to compete in several competitions. Besides building robots, the team participates in several beneficial outreach events. We host a yearly robotics competition called "Rumble in the Jungle" where 30+ middle and high school robotic teams manufacture a robot to battle it out in a complex game field. Lastly, we offer a program called RoboKids where we teach 50+ elementary and middle school students the basics of STEM and give them experience in building miniature robots. As the Robodox's core mission is to inspire the next generation of engineers and innovators, all our programs are free of charge to all students. That is why we are formally requesting \$5,000 (2k for building robots and 3k for our outreach initiatives) to fund the necessary materials needed to provide students a high quality experience in our programs.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

This grant will help the Robodox's mission of spreading the knowledge of STEM and grow our initiatives within Northridge West. First, by developing robots like the Pine Needle Bot will aid your community with its ability to clear pine needles from gutters and assist in storm drains in case of a rain surge. The other robots we build are for educational purposes where we design four feet tall robots that can move around, grab and shoot objects. This building process from designing, prototyping, to manufacturing provides our 45 member team professional engineering experience. During competitions, allows our members to gain valuable real life skills such as collaboration and working in a time pressured environment, we also provide technical support to other teams that come all over from San Fernando Valley including Northridge West. Next, our outreach activities are all free of charge and open to any students. For Rumble in the Jungle, we host a yearly robotics competition where 200+ middle and high school students attend, many schools come from Northridge West. This event serves as an educational opportunity for students to improve their engineering skills, network, and collaborate with others. Lastly for our RoboKids program, currently we are in partnership with two schools and offer introduction to STEM programs to about 70 students with plans to expand to 5 schools and over 120+ students starting with Northridge West. Overall all of Robodox's initiatives combined reach an audience of 1,000+ and we have been successful in our mission as 90% of our team members go on to major in engineering field and 70% of those who partake in our outreach programs continue on to be involved in STEM based activities. With Northridge West Neighborhood Council's support, we will be able to further our reach and enhance the ability to receive STEM education and training to the kids in Northridge West.
