BASIC NEIGHBORHOOD COUNCIL MEETING RULES

ALL MEETINGS ARE CONDUCTED IN ACCORDANCE WITH THE RALPH M. BROWN ACT AND ROBERT'S RULES OF ORDER. The basic council rules listed here are contained either in that act, the governing bylaws of this Council or in rules adopted by the Governing Board.

All Neighborhood Council meeting locations shall be compliant with the Americans with Disabilities Act.

DEFINITION OF STAKEHOLDER: [Bylaws Article 3 (G)] STAKEHOLDER shall mean all persons who live, work, or own property in the neighborhood and also those who declare a stake in the neighborhood and affirm the factual basis for it. The affirmation may require verification of said stake. Furthermore, each stakeholder class within the NWNC's boundaries has the ability to vote and run for office on the board. The geographic area of this council is from the 118 - Simi Valley Freeway south to Nordhoff and Reseda west to Corbin with the centerline of each street as the boundary. (Bylaws Article 5)

AGENDAS – Unless otherwise posted, the Northridge West Neighborhood Council meets the 2nd Tuesday of every month at 7:00 PM at the Beckford Avenue Elementary School Auditorium. The agendas for Neighborhood Council meetings contain a brief general description of those items to be considered at the meetings.

Items on the "Consent Agenda" may be voted on as a group unless a councilmember or stakeholder wishes to be heard on that item. In the event a councilmember or stakeholder wishes to be heard on an item, it will be called special and heard under the "Public Hearing" section of the agenda.

The presence of at least seven Council members shall constitute a quorum for the transaction of business. The Council may consider an item not on the agenda only if it is determined by a two-thirds vote of the existing council that the need for action arose after the posting of an Agenda.

COUNCIL DISCUSSION AND TIME LIMITS – Council members requesting to address the Council will be recognized by the Council President in the order requested. A motion calling the "previous question" may be introduced by any member during a Council debate. If adopted, this motion will terminate debate and the Chair will instruct the Secretary to call the roll on the matter.

Other Board Rules will be put in place and this section will be updated as necessary.

If the Motion to Reconsider is to be scheduled at the next meeting following the original action, then two items shall be placed on the agenda for that meeting: 1) a Motion to Reconsider on the described matter and, 2) a Proposed] Action should the Motion to Reconsider be approved. A Motion-to-Reconsider can only be made by a Board Member who has previously voted on the prevailing side of the original action. If a Motion-to-Reconsider is not made on the date the action was taken, then a Board Member on the prevailing side of the action must submit a memorandum to the Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall be in compliance with the Brown Act.

Unallocated Community Improvement balance is \$7,140 assuming item is approved, so new balance is \$6,695. Beautification (Williams)

TITLE: Oakridge Estate Plan Quiet Zone Amendment Request AUTHOR: Don Ward, Chair Planning, Land Use and Zoning Committee REFERRED TO: Northridge West Neighborhood Council by Planning, Land Use and Zoning Committee "WHEREAS The Oakridge Estate preliminary plans propose a "quiet zone" along the south end of the park adjacent to residential housing; and

WHEREAS constituents have expressed concerns the areas to the west side of the proposed plans are also adjacent to residential areas; and

WHEREAS the west side of the park is adjacent to a wash that can serve as an echo chamber that can amplify and distribute sound; be it

RESOLVED that the Northridge West Neighborhood Council urges Oakridge Estate planners to provide for a quiet zone along the western border of the park equal in size and effectiveness as the southern border; and be it further

RESOLVED that the Northridge West Neighborhood Council urges Oakridge Estate planners to accomplish a quiet zone without the use of barriers that would attract graffiti or vandalism; and be it further

RESOLVED that the Northridge West Neighborhood Council urges Oakridge Estate planners to investigate a public access pedestrian / ADA compliant entrance to the proposed park on the south end using public easement available between areas labeled watershed demonstration area and quiet zone."

f. NWNC to approve a Sidewalk Ordinance Resolution by Planning, Land Use and Zoning Committee.

TITLE: Sidewalk Ordinance Resolution AUTHOR: Don Ward, Chair Planning, Land Use and Zoning Committee REFERRED TO: Northridge West Neighborhood Council by Planning, Land Use and Zoning Committee

"WHEREAS Wednesday, Oct. 19, a joint meeting of the Public Works and Budget and Finance Committees discussed a "Point-Of-Sale" sidewalk ordinance which calls for property owners to accept responsibility for sidewalk repair; and

WHEREAS Los Angeles city has accepted responsibility for the sidewalks for nearly 40 years; and

WHEREAS the sidewalks are part of the public right of way and a significant component of the transportation system; be it

RESOLVED that the Northridge West Neighborhood Council urges the city of Los Angeles to continue to with current policy and accept responsibility to maintain the public right of way; and be it further

RESOLVED that the Northridge West Neighborhood Council urges the city of Los Angeles to work in conjunction with LADOT to better apply for federal Safe Routes to School grants to improve and repair sidewalk infrastructure; and be it further

RESOLVED that the Northridge West Neighborhood Council urges the city of Los Angeles to investigate and exhaust all options including seeking Federal ADA program grants to assist sidewalk infrastructure improvement and repair."

g. NWNC SUPPORTS THE VALLEY-WESTSIDE RAIL TUNNEL FOR THE I-405 CORRIDOR TRANSIT PROJECT RESOLUTION.

TITLE: SUPPORT THE VALLEY-WESTSIDE RAIL TUNNEL FOR THE I-405 CORRIDOR TRANSIT PROJECT AUTHOR: Valley Transit Coalition REFERRED TO: Northridge West Neighborhood Council by Planning Land Use and Zoning Committee (This motion is modeled after ones passed by the neighborhood council in Arleta, Northridge South, Panorama City, Reseda, and Sylmar.)

"WHEREAS the I-405 Freeway has the highest amount of average annual daily traffic (374,000 trips) of any highway in the nation (Source: U.S. Department of Transportation);

WHEREAS congestion on the I-405 Freeway takes a heavy toll on commuters, with 580,000 hours of delay for vehicles passing Getty Center Drive (Source: Caltrans);

WHEREAS San Fernando Valley stakeholders need a fast and reliable alternative to getting stuck in traffic on the I-405 Freeway;

WHEREAS currently there is no effective alternative corridor or transit line for the Sepulveda Pass for people going to and from the San Fernando Valley and the Westside, as shown by pleas from elected officials to "stay home" while the I-405 Freeway was closed in July 2011;

WHEREAS the Metro Red Line subway has reduced the growth of congestion on the 101 Freeway between the San Fernando Valley and downtown by carrying over 144,000 passengers daily (Source: Los Angeles County Metropolitan Transportation Authority, "Metro");

WHEREAS other regions of the County, such as the Westside, South Central LA, and the San Gabriel Valley, are lobbying hard to get more funds and to push their transit projects forward;

WHEREAS Measure R has set aside \$1 billion for a transit project to connect the San Fernando Valley with the Westside, plus additional funds to connect the north and south San Fernando Valley;

WHEREAS the federal government has provided a 60% match in funding for another Measure R rail transit project;

WHEREAS Metro has yet to define the type of project, such as rail, bus, or toll lane / auto toll tunnel;

WHEREAS the I-405 Transit Project is the final project in the Measure R timeline; be it therefore resolved that,

1. The Northridge West Neighborhood Council supports the development of a contiguous rail transit line from Sylmar Metrolink and Mission College to the Expo Line, and eventually to LAX as the plan for the 405 Corridor;

2. The Measure R Sepulveda Pass and Van Nuys transit projects should be studied together, rather than as two disjointed projects;

3. Further, the Northridge West Neighborhood Council supports a rail tunnel from Sherman Oaks to UCLA and Westwood as the mode of transit, versus the use of project funds for busways or conversion of High Occupancy Vehicle (HOV) lanes to toll lanes for this project;

4. Finally, the Northridge West Neighborhood Council calls upon the Mayor, the City Council, the County Board of Supervisors, legislators, Members of Congress, and Metro to take action to accelerate the timeline and obtain federal matching funds for this project so that San Fernando Valley stakeholders can enjoy its benefits as soon as possible."

j. Motion to approve funding up to for residential signs for total up to \$845.

a. Up to \$445 on Redwood for residential signs to suffice for remainder of this fiscal year for the volunteer sign maker. Labor is free. Wood needed for Volunteer, Jo Phillips, to continue making

signs. Jo confirmed wood shop class will continue next semester. This wood is for various signs such as Chateau Highlands, Devonshire Country Estates, Baton Rouge Estates, etc.

b. Up to \$400 for the big Wilbur/Lassen sign (3 planks of rough-cut redwood 2" x 12" x 18 feet = \$400 including tax) for Scottish Terrace Estates sign to be made by a volunteer, Jo Phillips. All labor is free of charge. Chris Williams already purchased the MDF material to make the letters for this sign. Jo Phillips already obtained the template letters in the same style as the Porter Ranch sign so she can route the letters.

Funding from Unallocated Community Improvement funds. Unallocated Community Improvement fund balance is \$6,695 assuming all of above items is approved, so new balance is \$5,850. Beautification (Williams)

- h. Motion for up to \$500 for Planter mix so volunteers can to use for the remainder of this fiscal year for tree and garden plantings. Funding from Unallocated Community Improvement funds. Unallocated Community Improvement fund balance is \$5,850 assuming all of above item is approved, so new balance is \$5,350. Beautification (Williams)
- Motion for up to \$800 for Plants and trees for the volunteers to install into Reseda Blvd. planters and tree wells that are within the NWNC area. LA City announced plans to remove these planters unless someone promises to maintain each planter. Clean Sweep Volunteers could maintain the planters thru this fiscal year and then NWNC should pay a contractor to do this work next year. Recurring work is water, remove trash and weeds.

Funding from Unallocated Community Improvement funds. Unallocated Community Improvement fund balance is \$5,350 assuming all of above item is approved, so new balance is \$4,450. Beautification (Williams)
