



LAMC 56.08

"No person having charge or control of any lot or premises shall allow any soil rubbish, trash, garden refuse, tree trimmings, ashes can or other waste or refuse to remain upon any sidewalk, parkway, or in or upon any street abutting on or adjacent to such lot or premises, or which will interfere with or obstruct the free passage of pedestrians or vehicles along any such street, sidewalk or parkway."

Your trees and vegetation must not hang lower than 9 feet over sidewalks.
