Examples from current NWNC Bylaws are below.

Section 3: Selection of Officers - Officer positions shall be filled every two (2) years at the first official Board meeting following their election or selection in Board election years, and one (1) year anniversary mark of the Officers' election in Board non-election years.

Section 4: Officer Terms - The Officers shall serve two (2) year terms and serve at the pleasure of the Board. They may stand for re-election every two (2) years.

c. Suggested change want is ["excused absences" as defined in the NWNC Standing Rules} which may be added as NWNC Standing Rules .

Currently on NWNC Bylaws are below.

ARTICLE V GOVERNING BOARD

Section 7: Absences - Any Board member who misses two (2) regularly scheduled consecutive NWNC Governing Board meetings or, optionally, three (3) total Governing Board meetings in a fiscal year will be automatically removed from the Board unless such absences are "excused absences" as defined in the NWNC Standing Rules.

- **d.** Note NWNC must send any NWNC Bylaws changes before May 2017 DONE for approval.
- e. Note NWNC Standing Rules can be changed by NWNC and does not require by DONE approval.
