

 - A. \$5,000 for NBF's Clean Streets/Clean Starts Program 2018 (assist the homeless and beautify Northridge) work projects in Northridge West area.
 - B. \$4000 for NBF, for maintaining the Tampa Median, Maintenance includes weeding, trimming and shaping the topiary and fixing and repairing the sprinkler system if needed and for additional topiary to be installed if permits are obtained. May, 2019

 - Kelly Sooter submitted clean up claims for Plummer at Corbin, Devonshire between Corbin and Tampa, and Wilbur between Devonshire and the 118 freeway. A claim was also filed regarding the damaged wall on Tampa above Chatsworth street.

- Highlights from Debra Scott, Bureau of Street Services presentation at the General Board Meeting: Did not cover last time.


