- 1. Meeting Call to Order at 6:32pm. Attendees included Kelly Sooter, Peter Lasky, Glen Wilson (7:00pm), Gail Lapaz and Mikkie Loi.
- 2. Public Comments on non-agenda items. None
- 3. Update on Utility Box Art project
 - Kelly provided an update on the Utility Box art project (attachment) including a comprehensive list of the non-profit and City organizations in the SFValley that have or are doing public art of this kind.
 - There is a meeting scheduled with CD12 on Tuesday, Febrary 4th to kick off the project.
- 4. Consideration of possible changes to the Tampa Median (10 minutes).
 - Existing topiary status agreed to hold on any further changes pending NBF / Don Larson situation
 - Potential additional topiaries agreed to not move forward with additional topiaries at this time.
 - Other landscaping options for consideration agreed to table this discussion
- Update on NWNC Project List for Don Larson and NBF NWNC is waiting for further response
 from the EmpowerLA and the City Controller as well as any support / response from NBF and
 Don Larson.
- 6. Other potential Beautification projects.
 - Gail mentioned a potential public art project on the wall infront of the Oakridge Estate which currently concrete (against the hillside)
 - Mikkie mentioned the ramp going to the second floor by Super King as a potential location for public art
 - There was discussion regarding the need for better equipment (weed wacker / mower) for the Clean Streets clean up days that we participate in. Peter asked that we first try to get the existing ones repaired, and if the cost is 50% or more than what it would cost to buy new, then we should add it to the agenda for the next General Board Meeting.
 - Glen agreed to move the NWNC materials including table cloths, banners and pop up to the storage unit this month.
- 7. Tree trimming status update, if any
 - Peter provide background on the Tampa median trees. The request to provide funding is with CD12 and Matthew Vallecilla.
 - Kelly to send Nextdoor post to NWNC stakeholders asking for tree planting suggestions.
