- 1. Meeting called to order at 7:02. Meeting attendees included board members Peter Lasky, Kelly Sooter, Gail Lapaz, Glen Wilson (7:15) and stakeholder Jasmine Dowlatshahi.
- 2. Comments by Stakeholders on Non-Agenda Items within the jurisdiction of the committee: None
- 3. Presidential Comments: None
- 4. Approval of January, 2019 Joint Executive Committee Meeting and Whole Board Meeting Minutes: PL motioned and KS seconded to approve the minutes. Minutes unanimously approved (PL, KS, GL).
- 5. Treasurers Report and discussion of the possible need to revise the budget
 - GW said that he needs to enter the last 3 NPG's into the funding system: CATS, Nobel Tovey Run and Granada Charter Robotics. PL asked that this be done soon.
 - KS provided a Budget tracking spreadsheet to review year to date (YTD) spend, projected full year (FY) spend, remaining available funds. (spreadsheet attached) Highlights are:
 - YTD spend \$17k
 - Projected FY spend \$36k (removed Outreach of CPR & Equip)
 - Ongoing monthly Office Expenses
 - Approved \$5k for Utility box
 - Unallocated remaining funds \$9k
 - o \$1k Office
 - \$3k Outreach (includes CPR & Equip)
 - o \$4.6k CIP
 - NOTE: NPG budget line item of \$9k has \$500 remaining. Any future NPG approvals would need to come from another budget line item.
 - PL requested GW provide an updated budget for the March General Board Meeting for the board to review and approve any needed changes.
- 6. Discussion of recommendations from the Outreach and Communication Committee for future speakers.
 - March = CERT speaker Patrick Hall / Glenn Dollar (KBE point)
 - April = Vector Control speaker Diane Guiterrez (KS point)
 - May = Public Works speaker tbd (PL working with Kevin James office)
 - GL recommended having someone to speak about the Coronavirus. KS to look into.
 - PL mentioned having a speaker on CA building regulations and the impact it has had on low income / homeless population. PL to follow up.
- 7. Discussion of the Budget Advocates White Paper CF-2200600 to be included in March GBM.
- 8. Presentation by Jasmine Dowlatshahi for the Salute to Recreation requesting approval of an NPG for \$2500.
 - Ms. Dowlatshahi presented the NPG request for \$2,500. The event will be similar to previous years without the fireworks show.
 - She has received NPG approval from NENC (\$2,500) and NSNC (\$1,500).
 - The event has been taking place since 1982 and draws approximately 50k people from the SFV.
 - Participation includes NWNC logo on all materials + booth for the weekend (includes table, chairs, pop-up, etc)
 - NWNC approved \$2,000 NPG for this event in 2019

- 9. Discussion and possible recommendation of the Beautification Committee to approve hiring a contractor to make alterations to the Tampa Median Topiary Frames, and other Beautification Committee recommendations, and ideas.
 - The Beautification Committee discussed possible next steps. (Notes issued separately from Beautification Committee Meeting Minutes Feb 27th).
- 10. Possible recommendations from the Bylaws Committee
 - Bylaws Committee Meeting Feb 20th reviewed GW recommendation and stakeholder Andrew Krowne recommendations.
 - KBE to provide additional comments related more to grammar / cleaning up the doc.
 - The Bylaws Committee Meeting did not review the recommended Standing Rules Ad Hoc notes.
 - A final Bylaws recommendation will be made at the March GBM for review and approval by the board.
- 11. CD 12 Town Hall Recap General observations included
 - + Good support from more NC's. (8 of 10)
 - + There were a couple hundred stakeholders at the Town Hall
 - + The candidates covered a wide variety of well-thought out questions provided by RS and the NC Town Hall committee
 - + The moderator did a very good job
 - + The event ran smoothly: room & stage set up, check in, etc)
 - The 3-day weekend may have impacted attendance (expectations were 300-400 vs 100-200)
 - There were a LOT of snacks. Moving forward this could be cut back dramatically. (Good news is we
 were able to return a lot. Total NWNC spend was \$70. Very cheap for an event of this scope) PL
 commented that he does not think the NCs need to provide food / snacks at these kind of events.
 - There was a lot more planning / work on RS part due to more NC participation
- 12. Discussion of presenting a recognition award for Distinguished Service Award, to local stakeholders or Groups by presenting them a certificate honoring their contributions. (Tabled)

 - KS presented an update on NWNC Outreach and website needs as well as webmaster vendor bids. The EC agreed to add to the March GBM.
 - KS provided bids to repair the 2 weed wackers the group uses for monthly clean up. This will be added to the March GBM
 - GL asked about getting NWNC shirts for new members / women sized shirts. KS to explore
 - KS reviewed the LA City request for tree planting (discussed at the Beautification Committee Meeting / Minutes)
