Input re: city budget. He would like us to ask Councilman Smith for open hearings to allow input from NCs. Also suggests that each NC contribute for example \$2,000 into a pool to retain consultants drawing on the expertise of retirees, etc. He believes this will help NCs perform their job better. He also recommends a charter amendment for an ex officio member which would be in the loop of the city council.
- b. Wes Rogers  
Expressed concerns over a bark beetle infestation in Northridge which is currently affecting many of our Canary Island Pines. Lack of water due to the draught and water conservation efforts has made the trees more susceptible to the beetle and Northridge has at least 25 dead trees that he has documented.

- i. Presentation by Noel Weiss -- Noel was an attorney on the companion lawsuits which resulted in a directive from the Court to remove two offending provisions of the City's ordinance implementing SB1818 and is currently advising (pro bono) the citizens of Valley Village on their appeal of the SB1818 project in their area. He was a candidate for the City Attorney in the last primary. He was also the attorney that represented the authors of the ballot argument opposing Measure B when they needed to go to court to support their argument.
- ii. Motion By Neil Perl to support the appeal of the Neighborhood Council of Valley Village and the Community's stakeholders to the City Council in connection with the development at 11933 Magnolia Blvd., Valley Village, California and to request a revision of the SB 1818 Implementation Ordinance to incorporate one simple provision which requires the developer to share its economic pro-formas with the City Planning Department and with the Community as to why a given concession or incentive is needed to make a project pencil-out

*Whereas the Planning Department did not require a review by Neighborhood Council Valley Village (NCVV) nor did it consider NCVV's input prior to approval, an action that demonstrates a disregard for the community, and is an inappropriate use of Planning Department discretionary authority.*

*And whereas the development of this project is not consistent with the prevailing character of community and is dramatically at odds with adjoining properties -- a failure of the Planning Department to uphold and negotiate vigorously to minimize transgressions of our General, Community and Specific Plans and to properly meld the city's planning obligations under the California Government Code,*

*And whereas the excessive height and density of this project will, in the future, be improperly cited as a precedent for variances and exceptions; which by its very outsized presence enable opportunities for projects that are not presently entitled to density bonus and further deteriorating the character of the neighborhood,*

*And whereas the current concerns of water drought should deny additional units being built. Thus imposing a further strain on the infrastructure in the form of power outages; water shortages and rate heights should not be borne by the current residents of Los Angeles so that Developers can make tidy profits while the public shoulders the ultimate and continued burden.*

*And whereas the Northridge West Neighborhood Council shares these grave concerns because they are matters that affect all of us and we consider them unacceptable.*

*Therefore be it hereby resolved that Northridge West Neighborhood Council supports the two appeals of the Valley Village stakeholders regarding the SB1818 development located at 11933 Magnolia Boulevard Valley Village, California [DIR-2008-1178-SPP]*

*Be it further resolved that the Northridge West Neighborhood Council requests a revision of the SB 1818 Implementation Ordinance to incorporate one simple provision which requires the developer to share its economic pro-formas with the LA City Planning Department and with the Community as to why a given concession or incentive is needed to make a project*

- b. Motion by Neil K. Perl Motion by Neil Perl, Treasurer, to approve a request for a Neighborhood Purposes Grant (NPG) in the amount of \$4,516.40 by Nobel Middle School. The purpose of the NPG is to 1) purchase printers for the classrooms along with the necessary supplies to run them, 2) purchase an upgrade to a program used by the teachers and 3) pay for the schools web-site for another year. The *Ad Hoc* NPG Evaluation Committee for this request voted to support this request. Representatives of Nobel MS will make a short presentation discussing the need for this Grant.

*Whereas the Neighborhood Purposes Grant (NPG) application submitted by Nobel MS has been available for review and comment by the public and duly evaluated by the Northridge West Neighborhood Council Board*

*Therefore be it resolved that the Northridge West Neighborhood Council approves the NPG submitted by Nobel MS in the amount of \$4,516.40 for the following community benefits:*

*The NPG will serve the students and staff at Nobel MS as well as the residents of the area. Improving the educational opportunities of the students in the current fiscal crisis is a benefit to our community because it helps make the citizens of tomorrow better able to live fruitful lives and to benefit the community in the future.*

- c. Motion by Neil Perl, Treasurer, to approve funding for Rincon Strategies to provide outreach for the Northridge West Neighborhood Council through pro active usage of social media and sending regular newsletters via e-mail to our mailing list. Adam Haverstock of Rincon Strategies presented plans for NWNC and discussed the status of the new web site.

*Whereas the Northridge West Neighborhood Council needs a more proactive outreach program to inform our stakeholders of the problems facing our community, the actions taken by the board to address these problems, activities the board supports for the good of the community, etc.*

*And whereas there is no member of the board who has the time or the ability to maintain a high level of outreach using the latest social networking platforms available.*

*Therefore be it hereby resolved funding a pro active outreach program using the latest in social networking tools be funded in an amount not to exceed \$1,890.00 for the year ended June 30, 2010. The work is to be done by Rincon Strategies at a charge of \$300.00 per month (Plus a 5% credit card charge {\$15.00}, if necessary) and will include updates to the Northridge West web site.*

meeting in which Rita announced that LA DOT will not be entering into any MOU with the NCs due to cuts in her department and the fact that she doesn't know what her department will look like in the coming year. Sr. staffers will be let go; they cannot be replaced; they will lose much of their institutional memory, etc.

- e. Motion by Neil Perl, Treasurer, was to be as stated below, but Perl requested that the motion and vote be tabled until February meeting.

*Whereas the Northridge West Neighborhood Council has previously allocated \$12,000.00 for beautification of Reseda Boulevard of which \$5,500.00 was set aside for maintenance of the Medians and trash removal, leaving \$6,500.00 for other beautification projects.*

*And whereas the Northridge 100 Celebration is taking place this year,*

*And whereas the NE/W Vision Committee is working on a program to provide maintenance of these planters, along with volunteers to provide labor and materials*

*Therefore be it hereby resolved that funding in an amount not to exceed \$\_\_\_\_\_ is allocated any unforeseen costs associated with the planting. Northridge East Neighborhood Council is also providing funding for these unforeseen costs. It is anticipated that all costs related to this planting of trees, etc. along Reseda Boulevard will be covered by donations and volunteers.*
