1. Roll Call

• President Peter Lasky called the meeting to order at 6.53PM (following SLO Peteque's presentation) and welcomed the fourteen attending stakeholders, along with the seven attending board members.

2. Flag Ceremony

Tom Johnson and a stakeholder held the flag as we pledged allegiance.

3. Reports/ Presentations by Public Officials

- Jessie Strobel from Councilman Englander's office addressed the NWNC
 - o Thursday, May 19, Mayor Garcetti's budget was approved, including:
 - Money for 300 additional LAPD officers
 - \$138m to combat homelessness
 - Funds to support an extra tree-trimming crew for the San Fernando Valley
 - The city council recently unanimously passed a bill to reform the LADWP; the next step will be its appearance on the November ballot.
 - Saturday, June 25, 6PM to 10PM, will be the [Re]visit [Re]seda Boulevard Summer Arts Festival between Nordhoff and Parthenia Streets; this will include local artists, music, vendors, dance performances, DJs, free giveaways, and food trucks.
 - Debbie Penman mentioned that Thursday's Operation Clean-Sweep could use additional assistance from Councilman Englander's office. Lately, they have merely five volunteers. Another stakeholder added that perhaps the management of the Northridge Fashion Center could contribute, as most of the Tampa Avenue traffic is going to or from the mall.
 - Colleen Pick added that Jessie Strobel has been very helpful in cleaning up excessive garbage near their business in Chatsworth.
- Melvin Canas from the Department of Neighborhood Empowerment (DONE) addressed the NWNC
 - As part of the new fiscal year budget, DONE will have additional staff in their Van Nuys office to support the community.
 - DONE requests an updated NWNC board roster, including email addresses. At the beginning of each month, DONE will send an email blast, including neighborhood council profiles, information regarding Neighborhood Purpose Grants (NPGs), etc.
 - Melvin suggested scheduling a board retreat on a Saturday morning; this may include training with DONE representatives.
 - Monday, June 20, at 6PM, DONE will host funding training at the Canoga Park Community Center,
 7248 Owensmouth Avenue.
 - Monday, June 27, DONE will host live Ethics Training at the Pacoima City Hall, 13520 Van Nuys Boulevard. This training is mandatory [every two years] for board members.
 - O DONE's Deputy City Attorney Danya is moving on to a new position at city hall; hence, DONE will acquire a new city attorney.

4. Special Guest Speaker: LAPD Senior Lead Officer Patti Peteque will speak about the benefits of Neighborhood Watch and how to start a Neighborhood Watch Program

- Patti Peteque from the LAPD addressed the NWNC
 - Her territory is the area bordered by Roscoe Boulevard, Lassen Street, Reseda Boulevard, and Tampa Avenue.
 - She has served with the LAPD for 23-years, including 15-years with the Devonshire Division. A year ago, she was promoted to Senior Lead Officer.
 - She continues to develop neighborhood watch programs because they have proven to be very helpful in reducing crime because the community is engaged and encouraged to report crimes.
 - o Patti requests financial assistance from the NWNC to purchase Neighborhood Watch signs and window stickers; many of the signs east of Wilbur Avenue have faded and should be replaced.
 - Tom Johnson asked about the Community Police Academy. This program is open to everyone. The
 current class is filled, but there is a waitlist for future classes. This includes a training simulator to test
 your reflexes in a real-life situation. This is separate from the reserve police officers training.
 - o Patti reported that there were recently two notable crimes in the community:
 - There was a residential burglary in Porter Ranch. The homeowner returned home and found the
 two men and two women within his house. As they drove away, the tires of their stolen vehicle
 blew. As they drove to the nearby Wal-Mart parking lot to investigate the tires, the police
 witnessed them removing guns from the trunk, and immediately took them into custody.
 - In the 9600 block of Topanga Canyon Boulevard, armed robbers took 250 iPhones. They got away in a white Chevrolet SUV; the robbers have not yet been arrested.

- a. Hyak Gasparyan formally resigned from the board effective May 11, 2016.
- b. Pamela Gentry formally resigned from the board effective May 19, 2016.
- c. The contract with American Heritage Landscape will expire on June 30; per vote of the Executive Committee, the Beautification Committee will recommend any future action. In addition, this committee may meet on Wednesdays (instead of Thursdays).
 - American Heritage Landscape (paid by NWNC) maintains Reseda Boulevard, between Kinzie and Superior Streets; previously, weeds grew 10' tall along this major thoroughfare. In the future, this expense may be shared with the Northridge East Neighborhood Council, as Reseda Boulevard is the border between the two neighborhood councils.
 - o In addition, American Heritage Landscape recently took down trees along Tampa and Wilbur Avenues.
- d. Appointment of Colleen Pick to the vacant General Business 2 Seat
 - o Colleen is a known entity and she will be welcome to return to the NWNC.
- e. Appointment of Mikkie Loi to the vacant At Large Seat 2
 - Mikkie is a known entity to the NWNC because of her efforts with the neighborhood watch and the emergency preparedness fairs. In addition, she has already taken the mandatory ethics and finance training.

 - Stakeholder Brian protested this motion by stating that this is a contract for goods and services, not an NPG. If approved, it could have a detrimental affect on the annual funds from the NWNC.
 - Peter Lasky replied that this NPG was written by someone from DONE and had approved by the Executive Committee. He added that we are currently in the "use-it or loose-it" situation with the current funds.
