Northridge West Neighborhood Council (NWNC) General Public Board Meeting Tuesday, 12 July 2016 Calahan Elementary School Auditorium 18722 Knapp Street, Northridge 91324

As we awaited a quorum, Urban Wildland conservation specialist Cathy Schoonmaker did a presentation before the NWNC.

- Ms. Schoonmaker has been with the National Park Service and Land Trust for over ten years; her specialty is researching coyotes, mountain lions, bobcats, and other wild animals.
- There has recently been a significant increase in coyote sightings throughout Los Angeles, including within ½-mile of downtown Los Angeles, as well as near the Veteran's Hospital/Sepulveda Ambulatory Care Center in North Hills.
- Among the coyotes tracked by the National Park Service and Land Trust is number 028, who has moved from Thousand Oaks to the San Fernando Valley.
- If the wild animals become a nuisance, they are killed, rather than relocated.
- The coyote's diet, as detected by their pooh in Agoura Hills, is 39% rodents, 30% fruit (they love figs), and 6% garbage, animal food, and small animals.
- While walking your dog, do not allow yourself to be distracted. Maintain a leash that is 6' long; a long (20') leash does not provide adequate protection.
- If a coyote walks by, do not ignore it. Get loud, big and make them know that they are unwelcome. Make the coyotes nervous so they do not come around. Think about loud things that you can carry to frighten the coyotes, or throw pinecones at them. Do not throw rocks at them, as we do not want to kill them, merely scare them.
- Suggestions from the National Park Service to avoid wildlife squatters include:
 - Bring pets in at night
 - o Keep your yard clean
 - Feed your pets indoors
 - Clean BBQs after usage
 - Install proper and high fencing
 - Do not permit overloaded trash
 - o Do not feed the wildlife; they have survived without us for generation
 - Be prepared to haze them. Spray water, yell, use an air horn, bang metal pots/pans, or put some coins into a metal can and shake it. Wild animals hate those noises.

1. Pledge of Allegiance

Peter Lasky led us in the pledge of allegiance.

2. Reports and Presentations by Public Officials

- Jessie Strobel, Field Deputy from Councilmember Englanders Office addressed the NWNC.
 - The city council is currently in recess until Friday, July 22.
 - Mayor Garcetti and the Board of Public Works recently introduced the Clean Streets Initiative; this will provide quarterly, block-by-block assessments of the city to build data and identify trends in street cleanliness. The system uses dash-cam video footage and GIS data to map, assess, and grade the degree of cleanliness of each street, alley, and sidewalk.
 - Wednesday, August 10, Councilman Englander's office will host a workshop at their office on 9207 Oakdale Drive.
 - Tuesday, August 2 is National Night Out; CD12 and the LAPD will host the Star Wars movie,
 Episode VII, the Force Awakens, beginning at sundown at the Northridge Park, 18300 LeMarsh
 Street.
 - o The 2nd annual Drive-In Movie, hosted by Councilman Englander, is in the works. We will let everyone know as soon as we know the date, title, and location.
- Ankur Patel, Field Representative for Scott Schmerelson, LAUSD Board Member for District 3, addressed the NWNC
 - o Friday, September 30, Mr. Schmerelson will host the first of his educational round-table. If interested, please contact Ankur.

3. General Public Comments on Non Agenda Items

- Tom Massimino and Barbara Hernandez from Crunch Fitness are looking to open another facility in the Northridge Center at 19500 Plummer Street. This new gym will only be accessible from the 2nd floor parking area; it will not interfere with the parking on the ground level, used by clientele of Super King and DSW Shoes. Another tenant will occupy the ground level of the two-story structure (previously occupied by Linen and Things). This new gym will be open 7AM to 7PM, but not 24-hours, as their gym at 10155 Reseda Boulevard is open all the time. They just wanted to come before the NWNC prior to their request for a Conditional Use Permit (CUP).
- Glen Bailey of the Northridge East Neighborhood Council (NENC) had a few committee and calendar announcements:
 - The Neighborhood Council Sustainability Alliance had their valley meeting last Saturday, July 9; they request that each neighborhood council have a representative on this subcommittee.
 - He serves on the executive council of the Valley Alliance of Neighborhood Councils (VANC);
 their monthly meeting on Thursday, July 14, will include a visit from the General Manager of
 the Department of Neighborhood Empowerment (DONE).
 - Saturday, July 30 will be Budget Day at the city hall. Council President Herb Wesson and City Controller Ron Galperin will be there; later, attendees will breakout into regional committees. Everyone is welcome at these meetings.
 - Saturday, September 24, will be the annual Congress of Neighborhood Councils at city hall.
 There will be over forty workshops for beginners as well as for experienced board members.
 Mayor Garcetti will also address the attendees.

4. President Peter Lasky Comments:

- Glen Wilson and Peter prepared and distributed a list of eight organizations that offer opportunities for both board members and stakeholders who may wish to participate. Board approval is not required.

- Peter, John Mah, and Brent Robinson were invited to a BBQ at Mayor Garcetti's residence. The mayor's wife, Amy Wakefield spoke about the accomplishments of the Garcetti Administration in increasing the number of women in key leadership roles within the city departments.
- Mayor Garcetti challenged the Neighborhood Councils to take an active role in helping to solve the problem of homelessness within each area.
- **5.** Presentation by Quality Mapping on the Zoning Application for a Starbucks to replace the Union Oil Station on the Northwest Corner of Tampa and Nordhoff, and approval of the recommendation by the Executive Committee to approve said application
 - Peter Elias of Quality Mapping reported that Starbucks would replace the Union Oil gas station at the northwest corner of Nordhoff Street and Tampa Avenue. A restaurant will be permitted on this commercially zoned property. The site will have to be delivered to Starbucks as a clean-site. Hence, Union Oil will need to remove the underground storage tanks and replace with clean soil prior to Starbuck's acquisition.
 - In five months, they will apply for a CUP, based on the following two elements:
 - They are very close to a residential apartment building across the street, and would like to be open from 5AM until midnight (rather than the accepted 7AM to 11PM).
 - This new Starbucks will have drive-through. The two driveways closest to the intersection will be closed, and there will be space for ten cars in the queue.
 - Starbucks will perform a traffic study; however, patrons will not be allowed to make a left turn across the double-yellow lined entrance.
 - The building will have stucco and wood siding with metal trim. The existing sign for the service station will remain, and be refaced to reflect Starbuck's logo.
 - This new Starbuck will have 65 seats, 53-inside and 12-outside.
 - Onsite deliveries will be made in the off-hours.
 - This Starbucks will not have a beer/wine license (as many Starbucks currently have).
 - The existing Starbucks inside the mall, as well as the one near Super King will remain; these are all owned by Starbucks, which does not have franchises.
 - This site is privately owned and leased to Union 76; it will be then be leased by Starbucks, it is not owned by the General Growth Properties (GGP) Mall Management.
 - Lloyd Dent made a motion stating that NWNC has no objection to the changeover from Union 76 to Starbucks; John Mah seconded the motion, and it passed.

- **6.** Approval of the recommendation by the Executive Committee to make a change of Webmaster's from Wendy Moore to Kristina Smith of The Mailroom
 - Wendy Moore addressed the NWNC. She serves approximately twelve neighborhood councils, and requests that this motion be tabled. She would like to reduce her service fee from approximately \$400/month (via her hourly rate) to a flat \$250/month. In addition to web hosting, Wendy writes a monthly article posted in the "North Valley Community Connection" newsletter and then reprinted

- onto to the website.
- Wendy requested that we have a member of the NWNC community dedicate 30-minutes a week to maintaining the Facebook (with 246 friends) and Twitter accounts.
- The new proposal from Kristina Smith would not include e-blasts (key to NWNC's civic engagement), which Wendy provides.
- Hrug DerManuelian asked what caused this action; Peter Lasky replied that in 2015, NWNC risked losing their funding by using an unauthorized vendor.
- John Mah made a motion to table this agenda item until the August meeting; Hrug DerManuelian seconded the motion, and it passed unanimously.
- 7. Consideration and motion to approve the recommendation of the Executive Committee regarding the Strategic Budget Package for fiscal year 2016/17
 - There were no comments from stakeholders regarding the Strategic Plan.
 - Glen Wilson made a motion to change the wording from "Strategic Budget Package" to "Complete Budget Package" and "Strategic Plain" to "Strategic Plan"; Peter Lasky seconded the motion, and it passed unanimously.

- In addition, 27% of the 2015/16 annual budget was spent in June. It would have been nice to spread it out more.
- Peter Lasky replied that in 2015/16, the budget was revised over five times, including the eventual resignation of a board member.
- Peter Lasky made a motion to approve the budget package; John Mah seconded the motion, and it passed.
